Everything You Need To Know About Exhibiting @ MYMR Tour

**Please READ carefully! & sign the complete document before making payment.**

## **VENDOR SUPPLIES:**

Every vendor space will be provided with following items per their selection of vendor purchase.

## **BADGES/WRISTBANDS:**

All badges/wristbands will be available for pick-up onsite at the Exhibitor Registration Desk in the lobby of the venue. Exhibitor Registration will be open during all move-in hours. The onsite contact person listed on the contract is responsible.

## **SALES TAX:**

All companies planning on selling products must be a registered entity in their state. **NO EXCEPTIONS!**

## **EVENT - EXPO HOURS:**

All companies must have a representative at their booth for the duration of the event(s). Event / Expo management is not responsible for any lost or stolen property incurred during this time.

## **MOVE-IN TIMES:**

All details will be provided in your Exhibitor Detail Email that will be sent out 45 days prior to each event.

## **SOUND:**

There are **NO** sound systems allowed unless previously approved by us. This means no stereo systems, PA'S, bull horns, etc

## Where is the venue located?

Location of Venue will be disclosed on the website (a) or in your Exhibitor Detail Email on or before June 30, 2021.

## Exhibitors ETA?

All exhibitors are expected to arrive between the hours of 10:00 AM -11:15AM. Due to our strict policy of arrival we do know sometimes unexpected issues arise and we ask that you **TEXT ONLY** 954-332-8642 or 954-268-4414 to make us aware of your situation. If you're a speaker that has a booth we ask that you have provided us with your staff name that will be setting up your vendor space 10 days before the event. If you fail to provide this information will result in an admission fee being applied at the time of arrival...

**\*Important\* No Show No Call will have you banned from future annual events with BOSS TALK EXPO.**

## Do I need to provide my own table linen?

No. We will provide **ONE** black table linen for a 6 ft. to 8 ft. table that **MUST** be left at the booth or you will be charged a fee of \$45.

## Can I bring a guest, family, friend, entourage, etc.?

We would like for everyone to attend & have paid an admission fee... Exhibitor booths should be accompanied only by the owner, representative (a) or up to one/two staff personnel that BOSS TALK EXPO is aware of in advance per your application provided. If you're a speaker... your guest entourage must pay an admission fee to be a part of expo/seminars. **NO EXCEPTIONS!**

## Premises:

Exhibitor warrants that the premises shall be left in original condition as upon arrival; this includes picking up trash at and around exhibitor premises. Non – removal of piping and draping.

**Indemnify:**

Exhibitors will indemnify and hold Boss Talk Expo harmless from all costs, losses, damages, or expenses including expense of litigation and attorney's fees, resulting from any person or property arising out of any act of omission of vendor of his employees or other representatives. The Boss Talk Expo, its officers, agents, or members shall not be held responsible for any loss or damage due to theft, fire, accident, or other cause but will use reasonable care to protect the vendor from such loss, (a) or conduct a thorough investigation shall an incident arise.

**WiFi:**

WiFi credentials will be available upon arrival at the venue.

**Hotel(s):**

The recommended hotels will be listed on the website and sent in Exhibitor Detail Email 45 days before each event.

**Additional Frequently Asked Questions: PLEASE READ THOROUGHLY****Will I be the only brand of my industry presented?**

When you go to Publix and look down the bread aisle do you see one brand of bread? **No.** Remember every company is different and brings a different value to each consumer. Think like a Fortune 500 Boss and Make Your Mark!

**I am not able to attend the event anymore – can I get a refund?**

**No.**

**I have contracted the virus – COVID-19 – can I get a REFUND?**

You will need to provide us with a Health Department / Test notice that states a POSITIVE result to be reviewed. This must be a request 10 days before the event – Once confirmed **ONLY** a 25% refund will be issued. We cannot issue a full refund due to the inconvenience of the company having to adjust accordingly for event(s).

### **Can my staff attend?**

Due to the CDC, we must maintain a certain capacity of attendees. Unfortunately, there can **ONLY** be a total of 2 participants to a vendor space. Should you fail to adhere to the guidelines you will be asked to reduce the staff immediately and possibly fined (\$250).

### **Can I attend if I already had COVID-19?**

If you did not contract the virus within 21 days of the event(s) you may proceed to attend. If contracted within that timeframe please advise us asap **PLEASE** so that we can take the proper measures to have you attend another one of our state events.

### **Do I need to have insurance?**

Not mandatory but recommended. Although the company / events will be insured we highly recommend that each vendor get insurance as **we are not** responsible for any theft, loss, or damaged items.

### **Will food be provided to vendors?**

No. Each vendor is responsible for their own food purchases, we asked that you purchase from a food vendor or site (a) or bring food of your choice. If you take any medication, please make sure to have food handy as per doctor's order. Please do not distribute food to any of the attendees as you have not been screening as a licensed food vendor.

### **I would like to sponsor a giveaway during the event to one of the guest speakers.**

Please email us for more details because each state may or may not have a special guest – you just never know.

**Can I have a flyer to advertise my appearance as a vendor?**

A standard flyer will be presented to whoever has purchased their booth; giving you the opportunity to advertise on any of your marketing platforms.
